Your privacy is important to Leaseweb Singapore Pte. Ltd. (hereinafter "Leaseweb SG"). Leaseweb SG duly informs you of Leaseweb SG's practices as unmanaged cloud hosting provider (unless explicitly provided otherwise) with respect to the possible processing of personal information while doing business with you ("Personal Data").

#### COMPLIANCE WITH DATA PROTECTION LAWS

Leaseweb SG complies with Singapore Personal Data Protection Act 2012 ("PDPA") and if to the extent applicable international data protection laws, in particular the EU General Data Protection Regulation 2016/679 ("GDPR"), both referred to as Privacy Acts.

### HOW LEASEWEB SG MAY COLLECT INFORMATION ABOUT YOU (IN OUR ROLE AS DATA CONTROLLER UNDER THE GDPR)

Leaseweb SG may collect your Personal Data when:

- You order a service from Leaseweb SG.
- You enter a promotion run by Leaseweb SG.
- You participate in a Leaseweb SG survey.
- You subscribe to a Leaseweb SG newsletter.
- You ask Leaseweb SG for more information about a Leaseweb service, or contact Leaseweb SG with a question, comment, or complaint.
- You submit an abuse notification to Leaseweb SG.
- You use the Leaseweb SG network, Leaseweb SG infrastructure and/or other Leaseweb SG services.

In addition, Leaseweb SG may collect your Personal Data as received from fraud-prevention agencies, referral partners, business directories and credit reference agencies.

# WHAT KIND OF INFORMATION LEASEWEB SG MAY COLLECT ABOUT YOU IN ACCORDANCE WITH THE PRIVACY ACTS (IN OUR ROLE AS DATA CONTROLLER UNDER THE GDPR) Leaseweb SG may collect the following information about you:

- Your business contact person's name, address, phone number, email address, business and ID registrations that may include photo and personal identification numbers and such contact details of legally authorized representatives.
- Your Leaseweb SG account information such as Leaseweb SG services you ordered, domain name registration information, the IP addresses
  assigned to you, your customer ID, fees owed and received, the use of Leaseweb SG services or any other information related to your account.
- Your contact with Leaseweb SG such as a notes or recordings of any calls you make to Leaseweb SG, a chat records when you engage in a chat session with Leaseweb SG, an emails or letters you send to Leaseweb SG or other records of any contact you have with Leaseweb SG.
- Information about your payment method, such as credit card number, bank account number or other banking information.
- Information provided by you to Leaseweb SG when you notify Leaseweb SG of a (suspected) breach of Leaseweb SG's acceptable use policies.
- Video footage of you when you are in a data center or the public space outside and inside our offices.
- Photo of you when you access a data center by using a personalized ID badge.
- Your biometric data including fingerprint when you access a data center.
- Documents and information that certify your identity.

## WHY LEASEWEB SG PROCESSES YOUR PERSONAL DATA IN ACCORDANCE WITH THE PRIVACY ACTS (IN OUR ROLE AS DATA CONTROLLER UNDER THE GDPR)

Leaseweb SG may process your Personal Data to:

- Process your Orders and Sales Contracts and provide services, which may include performing customer verification.
- Process vendors contact details for the procurement of services, and communicating with vendors to provide information about services of Leaseweb SG and affiliated entities.
- Conduct market research, retention and customer satisfaction surveys, (direct) marketing activities (including through email newsletters, social
  media and onsite/offsite and online/offline advertisement), sales activities to make personalized offers and quotations and offering promotions.
- Communicate with customers to (i) provide information about services of Leaseweb SG and affiliated companies, (ii) provide information about offers, Orders and Sales Contracts, provision of services, order status and payment, (iii) provide support and maintenance services, (iv) handle complaints, and (v) answer questions from (potential) customers.
- Perform financial processes, including to (i) calculate, invoice and collect service Fees, (ii) process financial transactions regarding the acceptance
  of Orders, and (iii) grant debt collection rights to third parties.
- Investigate creditworthiness and perform risk management, including to prevent overextending credit to (potential) customers and verifying whether (potential) customers will be able to comply with financial obligations.
- Investigate and process suspected violations of Leaseweb SG's Policies.
- Ensure the security of persons, goods and objects, and perform fraud detection.
- Conduct legal processes and comply with legal requirements, including in relation to legal proceedings, and evidence gathering processes, and complying with court orders.
- Comply with statutory obligations, including to (i) provide data to authorized authorities in the context of criminal investigations, (ii) comply with applicable data retention obligations, and (iii) the provision to third parties of data concerning customers in connection with an infringement of these third parties' rights.
- Establish the identity of customers or third parties, including provide access to data centers and our offices.

## SHARING YOUR PERSONAL DATA WITH THIRD PARTIES (IN OUR ROLE AS DATA CONTROLLER UNDER THE GDPR)

Leaseweb SG may share your Personal Data with:

- Its group affiliates including Leaseweb Global B.V ("Leaseweb Global") for the purpose of financial, tax, sales, (direct) marketing and operational tools and services (including the website <a href="https://www.leaseweb.com">www.leaseweb.com</a>, the Leaseweb Customer Portal and the Leaseweb API) that may be used to order or manage Leaseweb SG Services or to communicate with Leaseweb SG. Please review the Privacy Statement of Leaseweb Global on our website to learn about its practices with respect to the collection, storage, and use of your Personal Data.
- Suppliers involved in delivering the services you've ordered with Leaseweb SG.
- Credit reference, fraud prevention or business scoring agencies, or other credit scoring agencies.
- Domain name registries when Leaseweb SG registers a domain name on your behalf.

- Debt collection agencies or other debt recovery organizations.
- Leaseweb SG may also disclose your personal information as permitted or required by law.
- A Leaseweb SG customer, if you notify Leaseweb SG that this customer's use of Leaseweb SG services violates the Leaseweb SG's Policies or applicable laws.
- A third party that has claimed that your use of the Leaseweb SG services violates the Leaseweb SG's Policies or applicable laws (to the extent such sharing is required by law).

#### **RETENTION PROCEDURES**

Leaseweb SG will cease to retain its documents containing Personal Data, or remove the means by which the Personal Data can be associated with particular individuals, as soon as it is reasonable to assume that the purpose for which that Personal Data was collected is no longer being served by retention of the Personal Data, and retention is no longer necessary for legal or business purposes.

#### **LEGAL GROUNDS UNDER THE PRIVACY ACTS**

To process your Personal Data as described above, we rely on the following legal bases:

- 1. **Performance of a contract**: the use of your information may be necessary to perform the contract that you have with us. For example, if you use our services, we will use your information to carry out our obligation to complete and administer that service under the contract that we have with you.
- 2. **Legitimate interests and/or Business improvements**: the processing is necessary for the purposes of the legitimate interests pursued by us, for example information security. We also endeavour to provide you with the best suitable content through the website, emails and newsletters, to improve and promote our products and services, and to enhance our administrative functions, fraud detection and legal purposes.
- 3. **Consent**: For marketing advertisement (excluding operational communication as part of the services), you are free to withdraw your consent at any time.

#### CONSENT TO RECEIVE DIRECT MARKETING EMAILS AND WITHDRAWAL OF CONSENT

You are free to decide whether or not to share certain Personal Data (if any) with us for direct marketing purposes. However, if you decide not to provide certain Personal Data, or if you withdraw your consent thereto at a later moment, this may have affect how you experience our marketing for similar services. You are entitled to withdraw your consent by sending an email to the privacy email address listed below, or from direct marketing communication by opting-out from such communications. Upon receipt of your opt-out request, we will opt you out from the direct marketing list.

#### ACCESS CONTROL BY DATACENTERS

Providers of data centers in Singapore are not part of the Leaseweb group. Some data centers may require you to use a personalized ID badge, other data centers may require you to use a biometric access control system to gain unescorted access to the data center.

Customer is aware that a data center is responsible for the physical access and control of its premises as a Data Controller. Each data center is solely responsible for determining and executing its access control policies as indicated in their House Rules, including the processing of such biometric data for its access control system.

### TECHNICAL AND ORGANIZATIONAL SECURITY PROCEDURES AND DATA TRANSFERS

In accordance with the Singapore Personal Data Protection Act and the international data protection laws, in particular the GDPR, we observe adequate procedures to prevent unauthorized access to, and the misuse of, Personal Data. We use appropriate business systems and security procedures to protect and safeguard the Personal Data. We also use security procedures and technical and physical restrictions for accessing and using the Personal Data on our servers. Only authorized personnel are permitted to access Personal Data in the course of their work. Our business processes apply a series of security services are compliant with the industry security standards, including ISO 27001, SOC 1, PCI DSS.

Leaseweb SG has implemented the following, but not limited to, generic information security measures across its organisation: network segmentation, next generation firewalls, anti-virus software, full disk encryption of end-points, encrypted communication via SSL or VPN, Security Information and Event Management solutions, dedicated Security Operating Centre, monthly security awareness training, segregation of duties, role-based access permissions (based on least-privilege), secure disposal facilities of confidential information, periodic pentesting of public facing services, secure development training, integrated security monitoring during development, tools to enable employees to work secure (such as password managers), physical security zones. ## LEASEWEB SG IN ITS ROLE AS UNMANAGED IAAS CLOUD PROVIDER (UNLESS EXPLICITLY PROVIDED OTHERWISE) (DATA-PROCESSOR)

Any possible Customer Personal Data that is hosted, transmitted or processed on equipment you own (Co-location) or any possible Customer Personal Data hosted, transmitted or processed by Leaseweb SG in the delivery of the services on your behalf, is governed by this paragraph for Leaseweb as Data Processor, and any actions performed by Leaseweb SG in relation to such Personal Data shall be solely governed by the Sales Contract concluded between Leaseweb SG and its customer.

The customer of Leaseweb SG that owns the equipment (Co-location) or uses Leaseweb SG services, determines the purposes and means of the processing of Personal Data and therefore is to be considered the Data Controller in regards to such processing whereby Leaseweb SG has no logical access to such Personal Data.

## DATA RESIDENCY

The data hosted on your own infrastructure or on Leaseweb's infrastructure is located in Singapore.

### **DATA SOVEREIGNTY**

Leaseweb SG has no possesion, custody, or control over any Personal Data that is stored in the E.U. or that controlled by other Leaseweb Sales Entities.

In our role as Data Processor under the GDPR, we offer to EU-based customers the <u>Standard Contractual Clauses</u> to enable the lawful transfer of Personal Data from the European Economic Area ("EEA") and Switzerland to other countries globally, unless such country is qualified with an Adequacy

Decision. The Standard Contractual Clauses sets out Leaseweb SG's commitment to privacy and data protection when processing data in connection with the provision services to our customers and dealing with the transfer of Personal Data outside the EEA and Switzerland in connection with the

provision of such services.

#### DATA PROTECTION OFFICER

Leaseweb SG has appointed a Data Protection Officer ("DPO") to oversee the data protection responsibilities under PDPA and is also registered with the Dutch supervisory authority under number FG008004, positioned at our global headquarters in The Netherlands, readily availble during Singapore business hours if required. This office serves as our international center of expertise for international data protection laws compliance, in particular GDPR compliance, effectively centralizing our connection with the Dutch supervisory authority, as the permitted one-stop shop facility for the DPO. #### YOUR RIGHTS

In accordance with the Privacy Acts, you have a number of rights regarding your Personal Data and the processing thereof including but not limited to:

- You can view and, if necessary, change your Personal Data in your account at any time.
- You can request the Personal Data processed about you.
- You also have the right to obtain from us the erasure of your Personal Data after the termination of the Sales Contract ("Right to be Forgotten") in case and to the extent duly required and permitted.
- In addition, you may, under certain circumstances, have the right to restriction of the processing of your Personal Data.
- You have the right to object, on grounds relating to your particular situation, at any time to processing of your Personal Data.
- You have a right to object against the processing of your Personal Data for direct marketing purposes (e.g., per electronic message, per phone or per mail) by making use of the opt-out button in communications emails and/or rejected the opt-in.
- You have the right to receive your Personal Data, which you have provided to us, in a structured, commonly used and machine-readable format
  and have the right to transmit those data to another controller when the processing is based on your consent or is necessary for the performance
  of a contract.

#### RIGHT TO LODGE A COMPLIANT WITH YOUR LOCAL SUPERVISORY AUTHORITY

You have a right to lodge a complaint with your local supervisory authority if you have concerns about how we are processing your Personal Data. We ask that you please attempt to resolve any issues with us first, although you have a right to contact your supervisory authority at any time. If you make a complaint, we will endeavor to respond to it as soon as possible.
